

2024 Chamber of Commerce Vendor Application Jack Daniel World Championship Invitational BBQ October 12, 2024

Each space is a 10x10 uncovered area around the Town Square and thru parking lot of the County Annex at the entrance of the Wiseman Park. Locations will be determined by the type of product sold and availability.

All booths must be tent/canopy type booths. Tents must be tied down. No trailers or food trucks. Food spaces are reserved for local/nonprofit organizations.

Each 10x10 space is provided at \$75 per space \$100 for food vendors. Vendors will need to bring their own tents, tables, and chairs as this is an outdoor event. We offer 90 spaces but fill up fast. Please get your applications in as soon as possible to secure your space. A late fee of \$50 will be charged after September 30th if spaces are still available.

Electricity is available on a limited basis and an additional fee of \$25 per 20A plug. These spaces are located on the Square with your back to the Courthouse (closed).

Food spaces are reserved for local, non-profit organizations. All food vendors must be pre-approved.

New vendors will need to submit pictures of their setup and products with the application in order to be approved.

The event goes on Rain or Shine. There are no refunds.

Set-up times will be Friday night from **6:00pm-8:00pm (Friday is NOT an event day)** or Saturday morning from **6:00am to 8:00am**. Please do not enter the event area for setup before 6:00 on Friday night. The Sheriff's Dept. will be trying to close the town square and clear the area for the event. Vendors will be allowed to line up at the entrance at 5:45. Please allow a lane open for emergency vehicles.

Vendors will receive an email confirming their acceptance and include a vendor window display. You must have this in your car window in order to enter the area Friday night or Saturday morning. There are multiple stopping points—the display will help expedite the entrance times. Your space assignment will be given to you as you check in.

The event on Saturday typically runs from 9:00-5:00. The Sheriff's Dept. will remove the roadblocks and allow vendors to pack up when the crowd has subsided, and it is safe to drive in the area.
